**ACCOUNTS RECEIVABLE POLICY**

Customers seeking a credit account with the Benton County Solid Waste Disposal Commission must complete a Credit Agreement form with credit references. Credit references will be checked before the agreement will be considered for approval.

The Commission may refuse credit to any one person, business, or entity at their discretion.

Accounts not paid within 30 days of statement date will be charged 1.5% per month late charge on the over due balance.

Accounts **not paid** in full within **40 days** of the statement date will no longer be able to charge and must pay in cash. These accounts will be turned over to our Attorney for collection.

Once an account has been cancelled it can only be reestablished by submitting a new Credit Agreement form to be reviewed and acted on at a regular monthly meeting of the Benton County Solid Waste Disposal Commission.

With the exception of Municipalities/Governmental Subdivisions, there will be **no third (3<sup>rd</sup>) party** accounts. The party doing the hauling will be responsible for the landfill fees and the materials in that load.

The Commission may establish financial liability for both the hauler/contractor and their customer by requiring both parties to sign a Contractor's Agreement for demolition or construction projects.

This agreement is made and entered into on the date below written, by and between Benton County Solid Waste Disposal Commission (Commission) and the undersigned party.

The Commission is a governmental agency which operates a solid waste disposal facility in Benton County, Iowa, which the undersigned desires to use for the disposal of solid waste owned and/or being hauled by the undersigned; and

The undersigned hereby makes application to the Commission for permission to pay for the disposal services offered by the Commission subsequent to the time the solid waste is disposed of at the Commission's facility; and

**IT IS THEREFORE AGREED AS FOLLOWS:**

1. The Commission agrees to extend credit to the undersigned from the date of disposal, by the undersigned at the Commission's facility, to 30 days past the date of the invoice where the disposal charges are first billed.
2. The undersigned agrees to pay for all solid waste disposed of by the undersigned at the Commission's facility, in accordance with the rates for disposal as established by the Commission
3. Any payments not made on or before 30 days past the date of the invoice where the disposal charges are first billed, shall accrue interest at the rate of one and one-half percent (1.5%) per month, which amount the undersigned agrees to pay.
4. The undersigned acknowledges that credit privileges will be revoked if the undersigned's account is not paid in full by 40 days past the date of the invoice where the disposal charges are first billed.

**AGREEMENT BY OWNER AND CONTRACTOR WITH  
BENTON COUNTY SOLID WASTE DISPOSAL COMMISSION FOR PAYMENT**

Now on this \_\_\_\_\_ day of \_\_\_\_\_, \_\_\_\_\_, the following is agreed to by owner, contractor and the Benton County Solid Waste Disposal Commission (Commission), as follows:

1. Definition of owner: Each party understands that "Owner" means the owner or tenant causing the demolition of a building, or other improvement, which generates construction and demolition debris which is subsequently brought & deposited at the landfill site operated by the Commission.
2. Definition of Contractor: A "Contractor" is a person employed by an owner to remove construction and demolition debris that is deposited at the Commission's landfill site in Benton County, Iowa.
3. Financial Obligation: It is hereby agreed that both owner and contractor shall be equally responsible for all landfill fees and charges generated by the deposit of construction and demolition debris at the landfill site operated by the Commission. Both owner and contractor shall be equally liable for payment of all such charges and fees.
4. Consideration: Consideration for this contract exists based upon the Commission allowing the deposit of construction and demolition debris and the owner and contractor depositing such debris. A copy of this agreement has been received by each party hereto and each person executing this agreement is duly authorized to do so individually or on behalf of a corporate or business entity identified.
